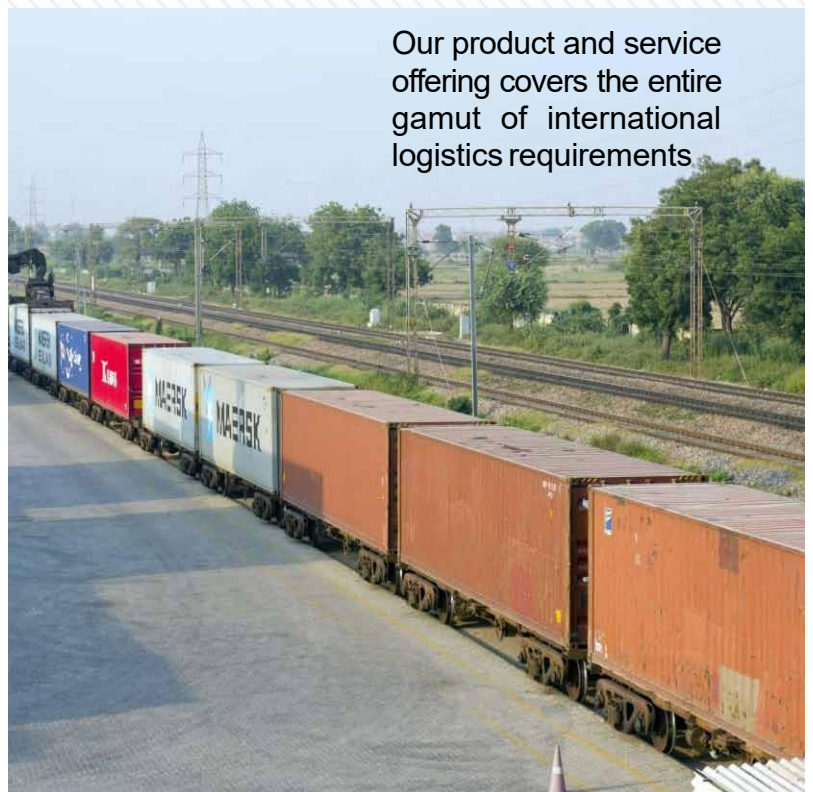
A Strategic Location

The ICD (outlined in yellow) is located at Faridabad, just off the Delhi–Mumbai National Highway 2, and adjoining the Delhi–Mumbai main railway line. The KMP expressway runs nearby and the Taj Expressway is being constructed adjacent to the ICD.

As ACTL has its own railway siding, the location allows for direct and unparalleled connectivity between the industrial and consumer zones in north India and the Gateway ports, by both road and rail.

Further, with proximity to the proposed Dedicated Freight Corridor (DFC) and Delhi–Mumbai Industrial Corridor (DMIC), ACTL is uniquely located to take advantage of the dramatically reduced transit times and value additions that these growth corridors will allow.

Extensive Infrastructure and end-to-end Solutions

ACTL is built over 24 acres, most of which comprises the container yard. The Administrative Block has 483 sq. meters over 3 floors of office space and the covered Export Warehouse is spread over 6125 sq. meters with provision for doubling the capacity by adding a mezzanine floor. We ensure smooth operations through:

- ▶ A large fleet of trailers for bonded and domestic transport requirements.
- ▶ A complete workshop for repair, maintenance and cleaning of containers.
- ▶ Computerized operations with a dedicated Business Center.
- ▶ 100 percent power back up.

- ▶ State-of-the-art equipment that ensures proper handling of cargo.
